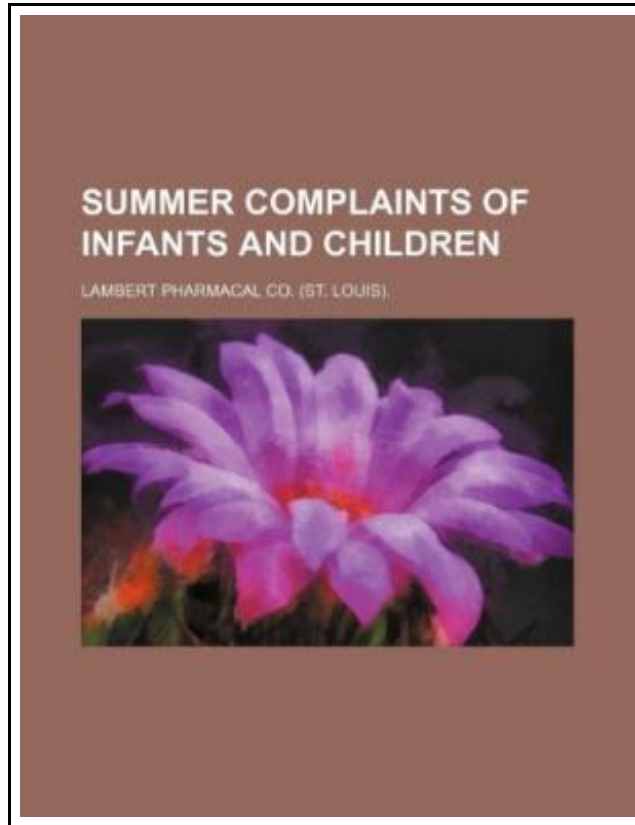

After which the following will be found efficient: Be Tr. opil camph. Spts. camphor, Syr. rhei, Syr. zingiberis, aa ss. Listerine (Lambert s) g j. M. Sig.--One teaspoonful every two hours until discharges become normal.
